Applicant's Declaration:

I/We hereby request that Goondiwindi Regional Council supply bulk water under section 8 of the Drought Management Plan and that I/We have read, understand and consent that:

- The household is located within the Goondiwindi Regional Council area and within a drought declared area as determined by the Department of Agriculture & Fisheries;
- The household is not connected to Council's reticulated town water supply;
- The approved quantity of water will be based on the number of persons residing within the household and the water consumption target under the current water restriction level;
- The number of persons residing within the household is true and correct;
- The approved quantity of water will be for a specified number of days and that a subsequent application will not be permitted until the next eligible application date;
- The water is for domestic household purposes only;
- The minimum load per collection is 1,000L (1kL);
- Water collected by a non-permitted water carrier shall not be used for human consumption.
