#### 7.7. TS102 – Auslink Interest Expenditure

Council received \$1,240,500 under the Australian Government Auslink Strategic Regional Program for 2 projects not under Council's jurisdiction. One project, namely Glenlyon Dam Road Upgrade (\$365,500 subsidy) is in the former Stanthorpe Shire and the other, namely Talwood Boonanga Road Bridge Replacement (\$875,000 subsidy) is a Department of Main Roads project. The funds were deposited in the former Waggamba Shire Council's bank account around 30 June 2007.

It is a requirement of the funding approval and yearly audited acquittal that Council demonstrates that any interest earned is spent on road construction or maintenance activities in the following year.
